Description of Basic Services: We offer Waldorf enrichment classes for Early Childhood with an emphasis on creative play, the outdoors, daily rhythm, meaningful work, arts/crafts, cooking, gardening, orchard/harvesting, farm chores and caring for animals. Our regular school-year program runs from Labor Day to Memorial Day. We do allow monthly payments for our annual program. We are open from 8:15a – 2:30p, 4 days a week (closed Mondays). We offer a 12:30p or a 2:30p pick-up for children in the PlaySchool (3 & 4 year olds). PlaySchool-aged children staying until 2:30 agree to nap from 1:00p-2:30p. All the children in our FolkSchool (older 4’s, 5 & 6 years old) are dismissed at 2:30p (no nap). Our organic and freshly made vegetarian snack (free of wheat, dairy, sugar, peanuts, preservatives, coloring, and additives) is served about 10:00a. We ask that children arrive between 8:15a-8:45a, and our dismissal times are 12:30p & 2:30p. Rates are based on two-day/wk. attendance and are: \$380/mo. for the 12:30p pick-up and \$480/mo. for the 2:30p pick-up. **There is a \$30 discount for payments received prior to or on the 1st of the month, so payments of \$350 or \$450 are accepted IF they are made on or before the 1st of the month.** Please note that a late charge of \$1.00/minute will be charged for children picked-up after 12:30p or 2:30p. The child’s attendance days and hours are as follows for both Playschool or FolkSchool: Tues./Thur. or Wed./Fri. Early Dismissal 12:30p or Late Dismissal 2:30p. Payment Provisions: I, _____, parent of _____, agree to pay \$_____ per month for my child to attend BeeLoved Farm Waldorf Children’s Center. I understand that payment is due on the 1st of the month, **prior** to my child’s attendance. Thus, all services are paid in advance plus the “last month’s” fee is collected as well. **All payments are late if received after that 5th, at which time a late fee of \$30 late fee is due with payment.** Any unpaid tuition remaining by the 10th of each month bars a child from returning to School until all fees have been paid. Unpaid tuitions beyond the 15th jeopardize a child’s enrollment in the Playschool or FolkSchool unless payment arrangements are made between parents and School. Please note that this monthly fee does NOT change based on the number days your child attends and/or holidays in the month. Your tuition secures your child’s spot in the class and therefore, no credit is given for days a child misses School. The administrator must GIVE 30 days’ advance notice prior to any rate increases. Withdrawal of a child by parent without 30 days’ notice NEVER qualifies for a refund of tuition for any unused days. Termination of a child by the School ALWAYS includes 100% refund of fees paid for any unused days. The one-time registration fee (\$50.00) is nonrefundable. The materials fee of \$100 may be prorated at \$10/mo. As a private Center, BeeLoved Farm reserves the right to serve those children and families who best meet the need of the entire School and wider community. A \$30 charge for dishonored checks applies. This admission agreement remains in effect until either party terminates the agreement. NOTE: The State may send a Licensed Program Analyst (LPA) to the preschool for an unannounced inspection and/or inquiry. The LPA has the right to interview any child without obtaining parental consent.
